



Participation in Jewel of Nigeria beauty and Style Pageant ® Events

Rules and Regulations:

Limitation of Liability / Responsibility

The Jewel of Nigeria (TJN) also known as Nigeria's Orange Beauty Pageant is organised by All Times Promotions Nigeria Limited in Conjunction with Mena Communications Limited, Abuja

The Organisers, herein to be referred to in this agreement as **All Times Nigeria**, its officers, employees, and pageant personnel are not responsible for accidents, injury or theft incurred at the time of **the Jewel of Nigeria** Beauty Pageant ® or travel to and from.

All Times Nigeria or associates, subsidiaries are not responsible for negligence or fraud on the part of pageant sponsors, judges, or contract vendors (e.g., photographer, videographer, etc.) that may be providing products or services to contestants at the Jewel of Nigeria Beauty Pageant. **All Times Nigeria** is not responsible for negligence or fraud on the part of the host hotel.

All Times Nigeria is not responsible for arranging flights or intervening / resolving disputes surrounding travel to the host state/Area of the pageant competition. **All Times Nigeria** is not responsible for loss, theft, or damage caused to any and all prizes, gifts, and awards bestowed upon a contestant after these items become the property of the contestant. Contestant agrees to incur replacement and/or repair costs to lost, stolen, or damaged items including but not limited to: crown/tiara, sash, plaques, trophies, etc.

All Times Nigeria is not responsible for accommodating a winner of the pageant throughout her reign as the title Holder, but shall provide official travel arrangements and Hotel accommodations while on official trip anywhere in Nigeria or outside.

Publicity and Promotion

The decision of the judges is final and not contestable for any reason. By virtue of participation in the TJN Pageant®, Contestant agrees to allow **All Times Nigeria**, the right to use her name, likeness, voice and/or biographical information for purposes of publicity and promotion now and in the future. Contestant understands that her name, likeness, voice, and/or biographical information may be used on the internet, in print advertising, press releases and merchandise related to the TJN Pageant® (e.g. t-shirts, tote bags, hats, other apparel, and other promotional materials.)

Contestant agrees to release **All Times Nigeria** from liability for any injury resulting from publicity and promotion. Contestant agrees to waive any and all compensation for use of her name, likeness, voice, and /or biographical information for purposes of publicity and promotion.

Photography & Videography

Contestant and their families are permitted to take photos and video during events leading up to the on-stage pageant competition event. Cameras or videography will not be allowed during any on-stage competition events. Individuals who fail to comply with this rule will be asked to leave the venue without benefit of refund for admission ticket. The Official TJN Pageant Photographer and Videographer will make professional photography and videography available.

By submitting the entry form and fee(s) to THE JEWEL OF NIGERIA BEAUTY AND STYLE PAGEANT leading to the grand finale of the Pageant®, contestant agrees to abide by all policies, rules and regulations set forth by **All Times Nigeria**. Participation in the Jewel of Nigeria Beauty and Style Pageant® also indicates acceptance and agreement to abide by all policies, rules and regulations set forth by **All Times Nigeria**.

Contestant understands that any incorrect or untrue statement about her personal data, records and professional track record, or any violation of the terms of this agreement will disqualify her from participation in the final event or, in case she has won a title, will result in retroactive deprivation of such, as well as all the benefits and prizes received or to be received under her contract with All Times Nigeria.

Attestation

I understand that All Times Nigeria will be responsible for my accommodation and meals (Lunch and Dinner) during the pageant. I understand I would be required to share a room with other contestants.

In this competition I fully understand that applicants with bleached skins are not qualified to seek entry.

I undertake to pay upon receipt of the invoice for any other expenses such as laundry services, telephone calls, e-mails, drinks and all other personal expenses made by me.

I fully agree to accept the decision of the Judges and agree never to either protest against the final result or make any comment about it or offer my personal opinions to the press or any other person.

During the camping period I agree never to leave the group of organisers or contestants. I understand that I must not accept any invitation from any one who is not part of the officials of the pageant, be it for dancing or going out. I also agree never to give out my personal phone number (s) or emails addresses to any one.

Disqualification / Title Relinquishment.

If Contestant is disqualified or relinquishes, for any reason, any title awarded to her, all prizes must be returned in full, and in condition received. If for any reason, the Winner resigns or is disqualified, the 1st runner-up will assume the title and all prizes

CODE OF CONDUCT

Entrant affirms that she is and will continue to be a person of good moral character; that she has not committed and will not commit any act inconsistent with the highest standards of public morals and conventions or that will reflect unfavorably on the pageant, its representatives, sponsors and/or licensees; that she has not appeared in nude or provocative photographs for any film or publication prior to, during the preliminary or pageant finals, or during her reign should she become even a preliminary Winner.

Contestant will conduct herself in a courteous, professional manner at all times during TJN Beauty and Style Pageant and while representing the Pageant's ® title.

Contestant will not slander or libel other contestants, judges, All Times Nigeria, its associates, staff or anyone else involved with or connected to the Pageant®. Defamatory verbal and/or written remarks against All Times Nigeria will result in immediate disqualification, forfeiture of any and all prizes and awards won, and legal charges. Good sportsmanship is expected at all times. Disruptive behavior before, during, or after the pageant may result in disqualification, removal from the premises, dethronement and legal charges.

Contestant agrees to sign a Code of Conduct statement indicating agreement to abide by the terms specified here. Failure to sign the Code of Conduct statement does not in any way release Contestant from responsibility to abide by the Code of Conduct. All issues related to the Code of Conduct and consequences for violation thereof shall be determined solely and exclusively by All Times Nigeria. Contestant agrees to accept such determinations made by All Times Nigeria, both as to herself and others.

Contestants shall at the time of applying and the time of the contest be between the minimum age of 17 years old or the maximum age of 25 years old at her last birthday anniversary.

Contestants shall bear all the cost for their travel and wardrobe before and during and after the pageant baring only winners who may have wardrobe considerations as part of their prizes and in which case shall be limited to the value of the wardrobe and in accordance with the terms of the wardrobe sponsorship.
